### COVID-19 Remains a Critical Threat in our Area

We are saddened to report that a DMAT associate has passed away due to complications from COVID-19. Please keep this associate's family and coworkers in your thoughts and prayers. Our state and local communities continue to see a rise in COVID infections and hospitalizations believed to be caused by the Delta variant. We strongly encourage all associates to get fully vaccinated as soon as possible to protect yourself and your family members.

## Onsite Vaccine Clinic August 11 & 13

The Blount County Health Department will return to DMTN on **August 11 from 3:30PM-5:30PM** and **August 13 from 6AM – 9AM**. The locations will be at the **DENSO Visitor Center** (Building 101 Visitor Lobby) and **Building 203 Visitor Lobb**y (change from previous location - 202 Visitor Lobby).

Associates, their family members (ages 12 and older), contractors and temporaries wanting to be vaccinated for COVID-19 can visit the vaccine clinic to receive the first dose of the Pfizer vaccine. Appointments are not necessary.

If anyone receives the vaccination during their regular work schedule, their time will be counted as paid time. The vaccines will be given first come, first serve. Those at work should coordinate with their leadership the best time to leave their department to receive the vaccine.

Please take advantage of this opportunity to be vaccinated on paid work time. If our participation rate is low, this could be our last on-site vaccination clinic. ## Family Day Cancelled Due to Increasing COVID-19 Cases



## DMTN COVID-19 Weekly Summary

Since Friday, July 30, DMTN has confirmed positive COVID-19 tests for fourteen additional associates, bringing the total to 688 positive cases to date. To the right, you can see an overall summary chart for these fourteen cases.

These new cases were determined to be a result of social and household exposure. In accordance with North America guidelines, work areas have been sanitized with UV light. Other associates who may have been in close contact (within six feet for more than 15 minutes) have been asked to closely monitor their personal health.

We ask that you respect confidentiality, even if you believe you know who these individuals may be. Please join in wishing for their quick recovery.
